- 按發售價每股發售股份1.41港元計算，經扣除本公司就全球發售已付及應付的包銷費用及佣金以及估計開支後，本公司估計將收到全球發售所得款項淨額(於超額配售權獲行使前且不計及因根據首次公開發售後購股權計劃授出的購股權獲行使而將予配發及發行的任何股份)約113.7百萬港元。

根據香港公開發售提出的申請
